**Completed form & Payment**  
The full payment (CHECK ONLY) of any required vendor fees and this completed and signed form are required to reserve your space. Space is limited. *Sign up early to ensure your spot!* The form and the payment check should be received by **October 15, 2022**. **Spaces**  
Subletting or sharing of vendor space is strictly prohibited. Entirety of vendor's set-up, display, and working space must be within the space rented. If you need more than the 10'x10' space for your booth, you will be charged a prorated extra fee.

### **Game Table**

The games must be approved and meet our safety requirements. Please send us a detailed email describing the game table, its operations, its materials, and list all parties who would be running it. Prizes must also meet safety guidelines.

### **Food/Candy/Drinks**

**No food or drink items may be sold at this event unless you have registered with us as a food vendor** and have complied with all laws, licensing, insurance, permits, and health department regulations. No homemade food or homemade drinks may be given away or sold unless you have signed up as and have been approved as a food vendor. However, pre-packaged and unopened candy that has been sealed by a licensed food company and that meets health code safety standards may be given away at the event. Please indicate on page 1 if you wish to distribute candy.

### **\*\*\*IMPORTANT: Set-up/Hours of Operation/Teardown**

Location is in the heart of Tularosa, New Mexico on Granado Street.

**The event is October 29th from 5:00 to 8:00 pm.** Vendor set-up begins at 3 pm, the streets will be closed off at 3 pm. Tear down must be completed by 10:00 pm. **ALL Vendors (including Trunk-or-Treat participants) are expected to operate for the entire event, from 5:00 to 8:00 pm. NO EXCEPTIONS! (At all.)** Kids' game booths are expected to operate from 5:00 pm to 8:00 pm. All vendors & booths will need to supply their own tables, chairs, displays, & tents, as necessary.

**SUPER IMPORTANT! BRING BATTERY OPERATED LIGHTS FOR YOUR BOOTH!** It will get dark for about 45 minutes or so before we close-up and you want your guests to be able to see your stuff. Electricity access is limited and what we can provide will be reserved for the children's games and the bandstand.

### **Insurance and hold harmless**

All vendors and exhibitors must have their own liability insurance. Vendor is solely responsible for all dealings and actions, and holds the **Tularosa Arts and History Council**, its board, employees, members, supporters, partners, sponsors, volunteers, advertisers, the Village of Tularosa, and owners of the premises used to host the event harmless from all claims.

### **Legal Compliance/Taxes**

Vendor agrees to comply with all laws, licensing, permits, and health department regulations. Vendors are solely responsible for payment of all state and local sales tax as a result of any sales made during this event.

### **Product Restrictions**

The sale of any items bearing the name "**Tularosa Arts and History Council**" or any other variations related to this event are strictly prohibited unless sold by the **Tularosa Arts and History Council**.

### **Questionable Products**

The **Tularosa Arts and History Council** reserves the right to inspect, approve, reject or otherwise control the display, promotion or sale of products or services at its sole discretion.
